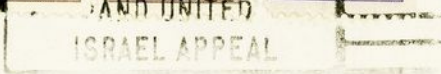

Sir:

While the Soviets offer their so-called peaceful coexistence to the West and try to sell their untrue slogans of freedom and friendship, the masses behind the Iron Curtain suffer under history's most brutal slavery.

The tragic news from Hungary has lifted these days, once more, the red curtain of Communist tyranny. A great number of innocent Hungarian teen-agers being jailed -for their alleged participation in the 1956 Freedom Fight - and now the Bolshevik government in Budapest has decided to execute them.

In the name of Canadians of Hungarian descent we ask you to halt this mass-murder in occupied Hungary. Please, urge an action through all possible political and diplomatic means to end the planned executions. The Human Rights Act is still in force and should be observed in Hungary too.

We hope you will be in favor of the attached appeal drafted by the Committee for Hungarian Liberation Inc. By supporting this rightful human action you will help to save the lives of many young Hungarians.

APPEAL


Confirmed reports indicate that from 150 to 350 children are being held in jail in Hungary, and that they will be executed when they reach their eighteenth birthday for their participation in the Hungarian freedom fight in 1956.

This is no longer war, this is not even cruelty, this is insanity! It is not necessary to excuse these children or forgive them, they committed nothing except to listen to their instincts to demand their rights as human beings. For this the all powerful Russian leadership will torture them with a prolonged stay in the death house and finally execution.

What can we Hungarians do to prevent these acts of perversion? If we ask the Russian Communist leadership to exercise compassion, in response they will torture and kill more Hungarians.

We can and must turn to you, one of the world's leaders and beg and implore you to act not merely within the confines of regulations but as a man, a human being, as one who believes in the dignity of man, to use the power of your office and the influence of your person so that in some manner, by some hitherto untried method these perverse acts which are debasing the dignity of mankind, be stopped.

To do nothing, although legally proper, will be advancing the gains of the Russian Communist clique. Remember, today it is the Hungarian Children, tomorrow it could be yours.
