### **Summary of Events**

From 5 through 7 October 1999, the Federation Commission on Missing Persons – Bosniak Side exhumed gravesites at ten sites in five general locations in the vicinity of Gacko. Twenty-eight sets of remains were recovered. All recovered individuals are presumed to have died during the war years.

A Physicians for Human Rights (PHR) Forensic Consultant was present for the recovery operations.

Remains were transported to autopsy facilities in the Federation of Bosnia and Herzegovina. Postmortem examination results had not been forwarded to PHR at the time of writing.

#### Narrative




Figure 1. Site Locations

The 11 sites are in or near Gacko (see Figure 1; Topographic Map Gacko; Sheet 2781 II; Edition 4-DMA; Series M709; Scale 1:50,000). Grid coordinates for all sites were determined using a Global Positioning System (GPS) unit (see Table 1).

Background information and descriptions of operations at the sites were not available at the time of report publication.

Postmortem examination results had not been forwarded to PHR at the time of report writing. Results will be filed with this report once received.
